## Circular No. 23/2015-cum-IMMM Amendment No. 06/2015

No: MAT/PMC/13(213)/2015

Sub: Time to be allowed to tenderers to quote against ONGC's tenders for procurement of Chemicals.

EPC, in its meeting (19/2015) held on 22.06.2015 has reviewed the aforesaid provisions of IMMM. Accordingly, relevant provisions of IMMM stand modified as under:
