Sub: Modifications to provisions of air freighting in respect of perforation materials

Reference is invited to the provisions for Air Freight / Consignment under para 20.5 of Integrated MM Manual and 30.3 of Standard Booklet MM01.

EPC, in its meeting (11/2018) held on 10.05.2018 examined aforesaid provisions and directed to modify the provisions in case of procurement of Perforation material, which is highly sensitive material and hence requires compliance to country specific legal/statuary requirements on its handling. For such material the order shall be directly placed on CFR basis.

In accordance, with the decisions taken in the aforesaid meeting of EPC, relevant provisions of Integrated MM Manual and Standard booklet MM01 stand modified as per Appendix-1 & Appendix-2 respectively.

Above guidelines should be meticulously followed by all concerned.

2.	30.3.1.	In case of air consignments the carriage of the consigned cargo shall be effected only through Air India/Indian Airlines. Where Air India/Indian Airlines do not operate its flights or there are strikes of flights or any other reasons beyond Air India/Indian Airlines' control, the suppliers/ONGC Air Cargo Consolidation Agency will obtain certificate from Air India/Indian Airlines showing their inability to accept the consignment or will obtain permission from ONGC. In all such cases, air freighting will be arranged through any first available foreign lines in the interest of ONGC to avoid delay. The SUPPLIER will hand over one set of documents (non-negotiable) i.e. invoice, packing lists etc. to ONGC Air Cargo Consolidation Agency/Air lines for delivery to the Port consignee. Also the SUPPLIER should intimate through cable/telegram/telex or Fax or e-mail all details of air freighting, the same day to port consignee alongwith the advance set of above documents.
