Sub: Changes in ICE system in respect of Purchase Preference Policy Linked with Local Content (PP-LC)

Reference is invited to Circular No. 19/2017 dated 16.05.2017 whereby the Policy to provide Purchase Preference (linked with Local Content) (PP - LC) notified by MoPNG was implemented in ONGC.

In order to capture the data pertaining to PP-LC in PO, ICE has developed a new functionality with the introduction of two new fields namely 'PPLC Code' and 'LC%' under Customer Data tab of Purchase Order, which shall bring into effect the following:

Placement of Purchase Orders in future: A.

While placing an order finalised on PP-LC bidder as per PP-LC policy in vogue, the suitable PP-LC Code shall be selected from the drop down menu, accordingly the LC% as applicable shall be automatically populated by the system for respective PPLC Code of Goods/service selected. The LC% shall be determined by the system as applicable on the date of NIT.

In case successful bidder is a non-PP-LC bidder/ the case where PP-LC policy is not applicable, code 'NLC' (Nil Local content) shall be entered against PP-LC code, which shall populate default value of 0.00 against LC% field.

Purchase Orders already placed: B.

- The past cases wherein PP-LC policy was implemented and successful bidder i) was a PP-LC bidder, POs for such cases shall be de-released and suitable PP-LC Code shall be selected from the drop down menu as per para (A) above, before releasing it again. This shall also include already executed Purchase Orders, if any.
- While Amending the POs, system will not allow to save POs without entering PP-LC ii) Code under Customer Data tab of Purchase Order. Hence, where PP-LC policy was not applicable/ PP-LC policy is applicable but successful bidder was a non PP-LC bidder, the PP-LC code 'NLC' (Nil Local content) shall be entered.

Above guidelines should be meticulously followed by all concerned.
