Safety performance of the competing organizations / installations is evaluated with the help of a criteria which takes into consideration, the total loss concept i.e. fatalities, fires, lost time, direct & indirect losses etc. and also the hazard potentials.

Speaking on the occasion, Mr. Jaipal Reddy said that "nothing is as important as safety" and also that "nothing is as difficult as safety", especially in the hydrocarbon sector which has its own set of complexities. He further added that a safety culture is rather difficult to practice in a developing country as ours since other sectors may not be as developed and hence pose a much stiffer challenge. He praised OISD for continually keeping itself abreast of the latest and best safety practices across the globe and appealed to Heads of all PSUs to ensure that a safety culture is imbibed by all of them in letter and spirit.

Mr. R.P.N Singh in his address said that these recognitions for best practices in Safety set standards and should inspire all the stakeholders to improve the safety standards in their respective fields. While addressing the gathering, he said that the issue of safety is crucial and potentially more hazardous in Oil & Natural Gas sector as the extent of damage is humongous and hence urged the industry leaders to set safety benchmarks for the world to follow.

Mr. G.C Chaturvedi, Secretary MoPNG said that the presence of Hon'ble Ministers is a testament of the importance accorded to safety and the issue of safety of non-negotiable and the industry should aim for zero tolerance for accidents. He further added that almost 80 percent cases occur due to negligence and not following the standard procedures set by OISD and hence no doubt avoidable.

Addressing the audience, Mr. L.N. Gupta, Joint Secretary, Refineries purported that "Safety is not expensive, it is priceless". He further added that although the overall accidents have come down in the last three years, there is still immense scope of improving by learning from the near-miss accidents and following the standard procedures more stringently.

Earlier, Mr. Hirak Dutta, Executive Director, OISD said that a 24X7 constant vigil is required for safety and that we need to build the safety culture in the industry. He urged the CEOs to build an appetite to share the bad news among everyone and that the whistle-blower must not be punished, but applauded.

Speaking after the awards ceremony, Mr Vasudeva said that as a responsive, proactive and prudent national oil company, ONGC accords the highest priority for HSE functions in its operations. The safety measures include both proactive and secondary to combat any unsafe situation and are systemic in nature. All operations are carried out after ensuring that two safety barriers are in place. These safety measures include in-built safety aspects during design phase, process safety, instrumentation & safety interlocks, emergency response, disaster management plans, etc. All these were done as per the international standards and in compliance with regulators requirement. He signed off by complimenting all ONGCians for these memorable achievements.
