Acknowledging the recognition bestowed on ONGC, CMD Mr. Sudhir Vasudeva reminded the house of the critical and invaluable role that the public sector has played in not just giving the nation's economy the definitive initial inertia but also sustaining its growth momentum thereon.

He said that the business ONGC was in does not allow us a moment of respite as at the end of the day; it no longer is just about a company, it becomes more of a national responsibility. Mr. Vasudeva believed that public platforms such as this would go a long way in mooring the public sector right at the centre of the national consciousness regarding India's economic and social strategy.

Chief Guest Dr. Veerapa Moily, Hon'ble Minister of Corporate Affairs in his inaugural address stated that the public sector has been, for an enduring period of time, providing a yeoman's service to the cause of the nation.
