Sub: Pradhan Mantri Suraksha Bima Yojana (PMSBY) and Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY).

Reference is invited to circulars vide No. 28(26)/97-IR dated 17.03.2016 and 13.05.2016 issuing guidelines for implementation of PMSBY and PMJJBY Insurance schemes launched by Govt. Of India. Copies of the said circulars are available on ongreports.co.in.

In pursuance of the aforesaid guidelines, all concerned are requested to incorporate following clause for additional coverage in the General Conditions of all type of **ongoing** Contracts wherein contractual workers are exclusively deployed by the contractor in ONGC for execution of the work including in LSTK contracts:

"The contractor shall educate all his/its workers deployed under this contract to obtain additional insurance coverage under Pradhan Mantri Suraksha Bima Yojana (PMSBY) and Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) through the participating banks. The intended beneficiaries shall give consent to join/enable auto debit of annual premium from their Bank Account. The beneficiaries shall submit documentary proof of such deduction, by bank, to the contractor. The contractor, in turn shall pay amount of the premium to the beneficiaries directly and submit the proof of such insurance coverage to the satisfaction of ONGC and claim reimbursement of the cost of the insurance premium from ONGC. The contractor shall also certify that the claim has not been preferred in the earlier contract of ONGC or otherwise.

ONGC after satisfying by verifying the required documents shall release the premium amount to contractor. In case a member is covered through more than one account, insurance cover will be restricted to one only. "

For future contracts enabling provisions have been incorporated in the standard contract conditions for procurement of services (including charter hire of rigs) as per Annexure-1.

Above guidelines should be meticulously followed by all concerned in all contracts wherein contractual workers are exclusively deployed by the contractor in ONGC for execution of the work including in LSTK contracts.
