## Sub: Seeking clarifications / confirmation / deficient document from the bidders.

Reference is invited to provisions under para 13.4 of Integrated MM Manual and standard tender conditions "on seeking clarifications of bids", which stipulate that during evaluation of bids, ONGC may at its discretion ask the bidders for clarifications/confirmations / deficient documents without allowing the bidder to change basic structure of bid. However, "vital criteria for acceptance of bids" of BEC for Services contracts against ICB tenders, stipulates that conditional / non-conforming bids shall not be considered and shall be out rightly rejected.

In order to remove contradiction between provisions and also to bring uniformity in the "vital criteria for acceptance of bids" of BECs for procurement of goods and services against IND/ICB tenders, relevant provisions of the said BECs stand modified as per enclosed Annexure-A.

Above guidelines should be meticulously followed by all concerned.
