**INSTRUCTIONS / REQUIREMENTS FOR PHYSICAL FITNESS TEST /  
INTERVIEW**

1. Candidates short listed for Physical Fitness test should report on the specified date as indicated in the schedule at ONGC, Assam Asset, Nazira at 8.30 AM.
2. In case of unconditionally qualifying the Physical fitness test, the candidates have to appear for a Personal Interview on the same day / next day at ONGC, Assam Asset, Nazira.
3. The candidates should be prepared to stay back for one more day, in case required. They have to make their own arrangement for stay. ONGC would not provide any accommodation for staying overnight.
4. No TA/DA will be given for appearing in the Physical Fitness Test / Personal Interview.
5. Selection is subject to possessing of Matric (Std X pass) and Technical qualification as notified in the advertisement, recognized by State Council of Technical & Vocational Training (SCTVT) / National Council of Technical & Vocational Training (NCTVT).
6. At the time of Interview the candidates are required to produce the following **in original** (without which they will not be allowed to appear in the Interview.)
  - i) Pass Certificate / Mark sheets of Academic and Technical qualification.
  - ii) SC/ST/OBC Certificate, if applicable, in the prescribed format **duly signed by Competent Authority of State Govt.**
  - iii) **In case of OBC Certificate, same should contain creamy layer clause also.**
  - iv) Employment Exchange Registration card.
  - v) Proof of Date of Birth.

7. In addition the candidates have to submit photo copies of all the documents as mentioned in **Para 6** above, duly attested & **one passport size recent photograph** at the time of physical fitness test / Personal Interview.

8. The candidates will be tested for the Physical Parameters – Height, Weight, Chest, Vision and undergo the following Physical Fitness test activities, as a part of the selection process for recruitment of Field Operators on Tenure Basis, on their own free will and consent, and will not hold ONGC responsible for any injury or mishap/ accident. Further, the candidates have to follow the safety guidelines as explained to them before the test.

- a) With one arm transport 20 kg object to 100 feet distance or 30 steps upstairs.
- b) With two arms transport 40 kg over 25 feet distance.
- c) Swing 5 kg sledge hammer – 15 times (5 times overhand, 5 times underhand, 5 times side arm motions).
- d) Climb a vertical ladder 100 feet.

9. Short listed candidates are being called for physical fitness test / interview, based on the documents / declaration made by them in their application submitted for the post of Field Operator on tenure basis and subsequent written test held on 07.10.2007. However, in case of non fulfillment of the minimum qualifying and physical criteria, the candidature will be summarily rejected and / or in case the declarations made by the candidates or any document / information submitted by them are found to be false or not in conformity with the prescribed eligibility standards for the post at any point of time, their candidature will be cancelled and if such an event happens after appointment, their services will be terminated without prejudice to ONGC's right to take any other action as it may deem proper.

10. Mere appearance / attending the Physical Fitness test / Interview, doesn't bind the Corporation to provide employment.

11. Canvassing directly or indirectly in any form will disqualify the candidature.
