
**Sub: MeitY notification notifying value addition calculation for 13 IT products in reference to Public procurement (Preference to Make in India) Order, 2017 – req.**

Reference is invited to Circular No. 49/2020 dated 26.10.2020, whereby Ministry of Electronics and Information Technology (MeitY) notification No. W-43/4/2019-IPHW-MeitY dated 07.09.2020 was enclosed for compliance.

Department of Promotion of Industry and Internal Trade (DPIIT) vide O.M. No. P-45021/37/2018-BE-II (E-21196) dated 23.11.2022 informed that it has received representation that several procuring entities are not applying provisions of PPP-MII Order, 2017 in procurement of IT products stating that MeitY vide its notification dated 07.09.2020 has notified applicability of PPP-MII Order only for 13 IT products.

In this regard, DPIIT has clarified that for 13 IT products notified vide MeitY's notification dated 07.09.2020, local content is to be calculated as per aforesaid MeitY notification. For all other products, local content is to be calculated as prescribed in PPP-MII Order 2017 itself. The said DPIIT O.M. dated 23.11.2022 is enclosed herewith for compliance by all.

Above guidelines should be meticulously followed by all concerned.

**OFFICE MEMORANDUM**

**Subject: Misrepresentation of MEITY F.NO W-43/4/2019-IP HW-MEITY Dated 7<sup>th</sup> September 2020 Notifying Methodology for Value addition calculation for 13 Items in reference to DPIIT Order NO P-45-021/2/2017-B.E.11 Dated 15.06.2017-reg.**

The undersigned is directed to refer to the subject cited above and to say that reference has been received in this Department from M/s Reprographics India vide its letter dated 28.10.2022 and 09.11.2022 (copy enclosed) alleging that several procuring entities are not applying provisions of PPP-MII Order, 2017 in procurement of IT products stating that MeitY vide its notification dated 07.09.2020 has notified applicability of PPP-MII Order only for 13 IT products.

2. In this regard, it is clarified that PPP MII Order is applicable on all procurements undertaken by Central Government procuring entities as defined in PPP-MII Order 2017 (last amended dated 16.09.2020). The Order also empowers the concerned nodal Ministry to prescribe the alternate method of calculation of local content if it considers that generalized definition as provided in PPP-MII Order, 2017 does not specifically address its concerns. Exercising powers conferred under aforesaid provisions, MeitY's vide its notification dated 07.09.2020 has prescribed the method of calculation of LC for 13 different IT products. Accordingly, for 13 products notified vide MeitY's notification dated 07.09.2020, local content is to be calculated as per MeitY aforesaid notification. For all other products, local content is to be calculated as prescribed in PPP-MII Order, 2017 itself.

3. All Administrative Ministries are requested to issue suitable instructions to its procuring entities, in this regard.
4. GeM is also requested to ensure that procuring entities do not circumvent PPP-MII Order citing aforesaid reasons in its portal.
5. This issues with the approval of competent authority.
