Sub: Request for updation of KYC, PAN, Nomination and Bank Account Details and Dematerlisation of Shares

Dear Member(s),

As per our records, you are an equity shareholder of the Company holding shares in physical mode. In this context, we would like to draw your attention to the SEBI Circular No. SEBI/HO/MIRSD/DOP1/CIR/P/2018/73 dated April 20, 2018 mandating updation of PAN and Bank details of shareholders in the records of the Company to facilitate credit of dividend directly in the bank account of shareholders.

Further, SEBI vide its circular No.SEBI/LAD-NRO/GN/2018/24 dated 08th June, 2018 & SEBI/LAD-NRO /GN/ 2018/49 dated 30th Nov, 2018 has mandated that all transfer of shares shall be permitted only in **DEMAT mode** with effect from 1stApril, 2019.

Accordingly, time and again, Company had taken various steps and also sent communication to members at the latest registered address available in our Records, requesting to update PAN, KYC and Bank Account details and dematerlise the Physical share certificates for easy liquidity.

Further, every year in the Annual Report and each correspondence w.r.t. transfer of Shares to IEPF authority due to unclaimed dividend, Company request its members to update their KYC and Bank Account details to seamless direct credit of dividend in their respective Account and dematerlisation of shares certificates.

1. Updation of KYC, PAN and Bank Account detail

SEBI vide its Circular dated 3rd November 2021 mandated that shareholders holding shares in physical form shall submit copies of PAN, KYC, updated bank details and registration/change in Nomination to the Company/ Registrar and Share Transfer Agent (RTA).

The investor service request forms for updation of PAN, KYC Bank details and registration/updation of Nomination are available on our website https://ongcindia.com.and forms are also enclosed with this letter for your ready reference.

Accordingly, Folios wherein any one of the cited details / documents (i.e. PAN, KYC, Bank Details and Nomination) are not available on or after 1st April 2023, shall be frozen by the RTA.. You will not be able to transact in your shares after your folio is frozen.

2. <u>Dematerialization of shares held in Physical mode</u>

SEBI has further mandated that requests for effecting transfer of securities shall not be processed unless the securities are held in dematerialized form within a Depository. Accordingly, shareholders who continue to hold shares in physical mode after 01.04.2019 cannot lodge request for transfer of shares without converting them in dematerialized mode. Shareholders need to open a DEMAT Account with any of the registered Depository Participant (DP) and get their shares dematerialized after submission of their share certificates to DP.

In view of the above directives from SEBI to avoid freezing of your folios, you are advised to submit the duly filled-in Investor Service Request forms (hard copies or through e-mail mode) along with the supporting documents **on or before 31**st **March**, **2023** to Registrar & Share Transfer Agent of the Company at below mentioned address:
