

Sub: Modification in provision on Air Consignments

Reference is invited to para 22.3.1(Annexure-II) of Standard Tender Documents for Procurement of OEM Spares (Imported) and in para 30.3.1(Annexure-II) of Standard Tender Conditions for Procurement of Goods (ICB), wherein provisions on how carriage of consigned cargo shall be effected in case of air consignments, have been stipulated. The said provisions have been reviewed.

Accordingly, relevant provisions of Standard Tender/Contract Conditions for Procurement of Goods (ICB) stand modified as per Annexure- 1.

Annexure-1**Statement showing existing vis-à-vis modified provisions of Standard Booklet No. ONGC/MM/01 (Annexure-II) and of Standard Tender Documents for Procurement of OEM Spares (Imported) (Annexure-II)**

Clause No.	Existing Provisions	Modified Provisions	Remarks
22.3.1(Annexure-II) of Standard Tender Documents for Procurement of OEM Spares (Imported)	In case of air consignments the carriage of the consigned cargo shall be effected <u>only through Air India/Indian Airlines. Where Air India/Indian Airlines do not operate its flights or there are strikes of flights or any other reasons beyond Air India/Indian Airlines' control, the suppliers/ONGC Air Cargo Consolidation Agency will obtain certificate from Air India/Indian Airlines showing their inability to accept the consignment or will obtain permission from ONGC. In all such cases, air freighting will be arranged through any first available foreign lines in the interest of ONGC to avoid delay.</u> The SUPPLIER will hand over one set of documents (non-negotiable) i.e. invoice, packing lists etc. to ONGC Air Cargo Consolidation Agency/Air lines for delivery to the Port consignee. Also the SUPPLIER should intimate through cable/telegram/telex or Fax or e-mail all details of air freighting, the same day to port consignee alongwith the advance set of above documents.	In case of air consignments the carriage of the consigned cargo shall be effected through <u>Airlines engaged by Supplier/ONGC Air Cargo Consolidation Agency depending on INCO term and instructions stipulated in the Purchase Order.</u> The SUPPLIER will hand over one set of documents (non-negotiable) i.e. invoice, packing lists etc. to ONGC Air Cargo Consolidation Agency/Air lines for delivery to the Port consignee. Also the SUPPLIER should intimate through cable/telegram/telex or Fax or e-mail all details of air freighting, the same day to port consignee alongwith the advance set of above documents.
