## Sub: Settlement of pending claims under Vivad Se Vishwas I-Relief for MSMEs

Kind reference is invited to PMC Circular No. 27/2023 dated 13.04.2023 and 36/2023 dated 05.06.2023 on Vivad Se Vishwas I- Relief for MSMEs-Revised Order wherein instructions issued by Department of Expenditure on Vivad Se Vishwas I-Relief for MSMEs were circulated to provide certain relief/benefits to MSMEs. Reference is also invited to even numbered letter dated 21.06.2023, wherein the list of pending claims were shared for timely settlement.

As per the guidelines, claims under VSV-I were to approved/rejected within 30 days from the submission of claim by the contractor on GeM portal and payment for approved claims were to be settled and updated on GeM portal within 30 days from the date of acceptance of claim. The deadline for submission of claims was over on 31.07.2023. However, it is observed that about 157 claims pertaining to ONGC are still pending for settlement.

As per instructions from Ministry of Finance, it has been directed by MoP&NG that all pending claims to be settled by 25<sup>th</sup> October 2023. The Ministry has also started daily monitoring of these claims w.e.f 18<sup>th</sup> October 2023.

List of pending cases related to Vivad Se Vishwas I-Relief for MSMEs downloaded from GeM dashboard till date is also attached for your reference.

In view of above, it is requested to advise all concerned at your work-center to take necessary action for settlement of the pending claims under Vivad Se Vishwas-I latest by 25.10.2023. Incharge/Head MM being the Primary user in GeM portal are requested to ensure compliance of settlement of pending claims and submit the ATR to VMC Cell (CPF 135944) in this regard, latest by 12 pm on 25.10.2023.
