Sub: Classification of Micro, Small enterprises (MSE) and Udyam Registration


Reference is invited to circular No. 21/2021 dated 23.07.2021 wherein it was stated that provisions of Integrated MM Manual, Standard Tender/Contract Conditions and BEC modified vide Circular 10/2021 dated 06.04.2021 stands reinstated as existing prior to circular 10/2021 and that such reinstated provisions shall be applicable upto 31.12.2021 in terms of Gazette notification No. S.O. 2347 dated 16.06.2021 or till further extended date, if any, notified by Ministry of MSME, Govt. of India. After such extended date the modified provisions as notified vide circular 10/2021 would be applicable.

The said date "31.12.2021" was further extended as "31.03.2022" vide Circular no. 05/2022 dated 25.01.2022 in terms of MoMSME Gazette notification no. S.O. 278(E) dated 19.01.2022.

Ministry of MSME has again extended the said date from 31.03.2022 to 30.06.2022 vide gazette notification no. S.O. 2134(E) dated 06.05.2022, which is attached herewith.

In terms of said notification, the existing enterprises registered prior to 30th June, 2020, shall continue to be valid only for a period up to the 30th day of June, 2022.

Above guidelines should be meticulously followed by all concerned.

In the said notification, in paragraph 7, in sub-paragraph (3), for the figures and the words, “31st day of March, 2022” the figures and words “30th day of June, 2022” shall be substituted.
