- **4.** M/s GSPC has given No Objection Certificate for transfer of the said environmental clearance dated 25th June, 2014 in the name of new company. M/s ONGC Ltd has submitted an affidavit to abide by the terms and conditions stipulated in the above environmental clearance dated 25th June, 2014.

- **5.** As per relevant provisions of the EIA Notification, 2006, the environmental clearance dated 25th June, 2014 to the above project granted by the Ministry, is hereby transferred *from* M/s GSPC Ltd *to* M/s ONGC Ltd, on the same terms and conditions under which prior environmental clearance was initially granted.
