Sampling, Bonding, Testing, De-bonding and Dispatch of chemicals. Sub:

Reference is invited to PMC Circular 06/2019 dated 25.03.2019, vide which it was clarified that for all chemicals, sampling at destination and testing by concerned RGL is to be done as per PMC Circular 03/2019. If testing facilities for some of the parameters are not available in RGL, the testing of these parameters can be done at outside reputed labs or manufacturer's lab by RGL. Suitable provision may be incorporated regarding testing in the technical BEC in consultation with RGL.

In partial modification to the above instructions, sampling at destination and testing of the Indigenous Chemicals as listed in Annexure-I will be done by Testing labs as mentioned against the respective Chemical. Sampling at destination and testing of other indigenous chemicals will be done by concerned RGL as per PMC Circular 03/2019.

Above guidelines should be meticulously followed by all concerned.
