## ONGC wins 7 oil blocks, OIL 4 in latest bid round

New Delhi, 22 October

State-run Oil and Natural Gas Corporation (ONGC) has won seven out of 11 geographical areas on offer under the fifth bid round under the Open Acreage Licensing Policy (OLAP). Oil India (OIL) won the remaining four blocks, upstream regulator Directorate General of Hydrocarbons said on Thursday.

OALP Round V is expected to generate immediate exploration work commitment of around \$400-450 million. The 11 blocks under this round are spread across eight sedimentary basins and include eight on-land blocks (six in Category I basin and one each in the country. Category II and III basins), two each in Category I and II basins), and one ultra-deepwater block (Category I basin). The current round has opened up approximately 19,800 square (sq.) kilometres (km) for investors.

The only private bidder during the round was Invenire Energy. "But all the 11 blocks have gone to public sector players, with ONGC winning the maximum of seven blocks," said a person aware of the development.

ONGC has won blocks in Bengal-Purnea, Cambay, Gujarat Kutch, Gujarat Saurashtra, and Mumbai basins. On November. the other hand, OIL won two blocks each in Assam (Assam Shelf and Assam Arakkan) and Rajasthan. This is the second round of auctions in the cur-



rent year. In January, all seven blocks that were on offer under the fourth round of OALP were awarded to ONGC. The round added another 18,510 sq. km to the total exploration area of

Of the seven blocks, five are shallow-water blocks (one located in Madhya Pradesh, while one block each in Rajasthan and West Bengal. The seven blocks are spread over three sedimentary basins, with resource potential of approximately 33 billion barrels of oil and oil equivalent gas.

An area of 136,800 sq. km has already been awarded under OALP I, II, III, and IV. The first four rounds are expected to generate an investment of approximately \$2.35 billion over the next three to four years in exploratory work alone. The expression of interest for the sixth and seventh rounds will be over by mid-

The Hydrocarbon Exploration and Licensing Policy, under which OALP blocks are awarded, adopts the revenuesharing contract model.

# ONGC, OIL win all blocks on offer in the fifth round of OALP bids

Oil and Natural Gas Corporation (ONGC) Ltd has won seven blocks while Oil India Limited (OIL) has won four blocks that were on offer in the fifth round of bids conducted under the Open Acreage Licensing Policy (OALP). In the four earlier bid rounds, 94 blocks spread over an area of 1,36,790 sq km were awarded.

OIL won two blocks each in the Rajasthan and the Assam Shelf & Assam Arakan basins in this round. ONGC won two blocks in Cambay, one each in Bengal-Purnea, Cauvery, Gujarat Kutch, Gujarat Saurashtra and Mumbai basins. Invenire Petrodyne, the only other player that participated in bids, did not win any blocks in this round.

The 11 blocks offered in the OALP Bid Round-V are located in Western Offshore (Saurashtra & Mumbai) & Eastern Offshore (Cauvery) and also spread across the states of Rajasthan, Gujarat, West Bengal, Odisha, Arunachal Pradesh and Assam over eight sedimentary basins. In this fifth round, 11 hydrocarbon blocks covering about 19,800 square kilometres were offered for exploration.

NEW DELHI, OCTOBER 22

STATE-OWNED OIL and Natural Gas Corp (ONGC) and Oil India (OIL) have won all the 11 blocks offered in the latest bidding round for oil and gas exploration blocks, the Directorate General of Hydrocarbons said on Thursday.

ONGC won seven blocks while OIL won the other four blocks, with only one bid coming from the private sector from Invenire Petrodyne Ltd.

ONGC had also dominated

the previous round of bidding, winning all six of the blocks offered in the fourth round, offered under the Open Acreage Licensing Policy (OALP).

Experts have said the lack of interest from private players in recent rounds of OALP bidding has been a result of a lack of policy clarity from the government and unsuitable taxation and regulatory conditions. A proposal by the Petroleum Ministry to reduce the oil cess charge on domestic production of crude has been rejected by the Finance Ministry, according to government sources.

Invenire Petrodyne Ltd was the only private bidder for one block.

While ONGC was the sole bidder for six blocks, OIL was the lone bidder in all the four blocks it bid for.

ONGC won all six blocks where it was the sole bidder and also the one block where Invenire Petrodyne had bid.

The previous bid round, OALP-IV, too had seen just eight bids coming in for seven blocks on offer. ONGC had walked away with all the seven oil and gas blocks on offer.

Prior to OALP-V, the government had awarded 94 blocks in four OALP bid rounds in the last two and a half years. These

94 blocks cover an exploratory area of about 1,36,800 square kilometers over 16 Indian sedimentary basins. In the latest bid round, about 19,800 sq km of the area was offered for bidding, according to DGH.

OALP-IV was the first round on revamped terms approved in February 2019.

Unlike previous rounds, where blocks were awarded to companies offering a maximum share of oil and gas to the government, blocks in little or unexplored Category-II and III basins are now awarded to companies offering to do maximum exploration programme.

The 11 blocks under OALP-V are spread across eight sedimentary basins and include eight on land blocks (six in Category-I basin and one each in Category II and III basins), two shallow-water blocks (one each in Category-I and II basins) and one ultra-deepwater block (Category-I basin).

At the time of the launch of OALP-V, DGH had stated that the round is expected to "generate immediate exploration work commitment of around \$400-450 million".

"An area of 1,36,800 sq km has already been awarded under OALP bid round I, II, III, and IV. These OALP bid round-V blocks would add a further 19,800 sq km. Overall exploration acreage of India would then increase to 2,36,600 sq km," it had said at that time.



# ONGC, Oil India pick up all oil & gas blocks on offer

These blocks have the potential to produce around \$400-450 mn

ALL oil and gas exploration blocks that went under the hammer in the fifth round of bidding were picked up by state-owned ONGC and Oil India Ltd (OIL). According to officials, the 11 blocks which were offered under the latest round have the potential to produce around \$400-450 million (₹3,000-3,300 crore).

Oil sector regulator Directorate General of Hydrocarbons (DGH) said in a notice on Thursday that the bidding round under India's Open Acreage Licensing Policy (OLAP) had seen ONGC winning seven blocks, while the remaining four went to OIL. The only private bidder who participated in the round-Invenire Petrodynedid not win the bid it made for a single block, which ONGC won. The remaining ten blocks saw only one bidder each, with ONGC the sole bidder for six blocks and OIL the sole bidder for the rest. The fourth round of bidding had also seen little participation from private bidders with just eight bids received for the seven blocks that went under the hammer.



All seven had been awarded to ONGC. The 11 blocks which went under the hammer in the fifth round are spread across eight sedimentary basins-eight are land blocks (six in Category-I basin and one each in Category II and III basins), two shallow-water blocks (one each in Category-I and II basins) and one ultra-deepwater block (Category-I basin). Including the fifth round, 105 blocks have been awarded under the OALP bidding system so far. Of these, Vedanta has won 51 blocks, OIL has won 25, and ONGC 24.

However, while there had been significant private sector interest in earlier rounds, the last few have not seen the same kind of participation. So far, the total area that has been auctioned out stands at 1.56 lakh square kilometers. The licensing policy has also been tweaked in February 2019, with blocks in little or unexplored category-II and -III basins now being awarded to companies offering to carry out maximum exploration programmes. Earlier, licenses had been awarded to companies who offered the maximum share of oil and gas to the government.

According to officials, the OALP offers bidders reduced royalty rates, no oil cess, marketing, and pricing freedom, freedom to carve out blocks they are interested in, and exploration permission forthe entire contract period.

## तेल, गैस क्षेत्र के लिए पांचवें चरण की बोली

## ओएनजीसी सात, ओआइएल चार ब्लॉक हासिल करने में सफल

नई दिल्ली, 22 अक्तूबर (भाषा)।

सार्वजनिक क्षेत्र की ऑयल एंड नेचुरल गैस कॉरपोरेशन (ओएनजीसी) बोली के लिए पेश किए गए नवीनतम दौर में 11 तेल व गैस खोज ब्लॉक में से सात हासिल करने में सफल रही है। उत्पादन नियामक हाइड्रोकार्बन महानिदेशालय (डीजीएच) ने गुरुवार को यह कहा। शेष चार ब्लॉक ऑयल इंडिया लिमिटेड ने हासिल किये। सरकार ने खुला क्षेत्र लाइसेंस नीत (ओएलएपी) के तहत पाचवें चरण की बोली में खोज व उत्पादन को लेकर 11 ब्लॉक की पेशकश की थी।

कुल 12 बोलियां प्राप्त हुईं। कुल 11 ब्लॉक के लिए सात बोलियां ओएनजीसी और चार ऑयल इंडिया लिमिटेड (ओआईएल) की आईं। बोली प्रक्रिया 30 जून को समाप्त हुई। इनवेनाइर पेट्रोडाइन एकमात्र निजी कंपनी थी जिसने एक ब्लॉक के लिए बोली लगाई थी।

ओएनजीसी छह ब्लॉक के लिए एकमात्र

बोलीदाता थी जबिक ओआइएल चार ब्लॉक के लिए अकेले बोली लगाने वाली कंपनी थी। ओएनजीसी को सभी छह ब्लॉक मिले। इसके अलावा उसे वह ब्लॉक भी मिला जिसके लिये इनवेनाइर ने बोली लगाई थी।

इससे पहले, ओएएलपी-चौथे चरण की बोली में भी सात ब्लाक के लिए केवल आठ बोलियां आई थीं। ओएनजीसी पेशकश किए गए सभी सात तेल और गैस ब्लॉक हासिल की थी। डीजीएच के अनुसार बोली के ताजा चरण में करीब 19,800 वर्ग किलोमीटर क्षेत्र की पेशकश की गई थी।

ओएएलपी-5 के तहत 11 ब्लॉक आठ अवस-ादी बेसिन में फैले हैं। इसमें आठ भूमि पर स्थित ब्लॉक है। दो छिछले जल क्षेत्र में और एक गहरे जल क्षेत्र में है। ओएएलपी के पहले चार चरणों में 94 ब्लॉक आबंटित किए जा चुके हैं। इसमें वेदांता ने सर्वाधिक 51 ब्लॉक हासिल किए। वहीं, ऑयल इंडिया ने 21 और ओएनजीसी ने 17 ब्लॉक हासिल किए। ओएएलपी-5 के बाद ओएनजीसी के ब्लॉक की संख्या 24 और ओआईएल की 25 हो गई है।

# CIL fuel allocation under exclusive auction for non-power sector rises sixfold in H1

allocation under the exclusive eauction scheme for the nonpower sector rose almost sixfold to 13.44 million tonne (MT) in April-September this fiscal.

Coal India (CIL) had allocated 2.31 MT of dry fuel to the sector under the scheme in the corresponding period of the previous fiscal, according to the latest government data.

This growth comes amid CIL looking to tap the non-power sector to consume its coal. However, there was no allocation of coal by the PSU under the scheme last month, the data showed. For the entire fiscal (2019-20), the PSU's coal allocation under the scheme dropped to 8.03 MT from 11.36 MT in FY19. —PTI
