Sub: Classification of Micro, Small enterprises (MSE) and Udyam Registration

Reference is invited to circular No. 21/2021 dated 23.07.2021 wherein it was stated that provisions of Integrated MM Manual, Standard Tender/Contract Conditions and BEC modified vide Circular 10/2021 dated 06.04.2021 stands reinstated as existing prior to circular 10/2021 and such reinstated provisions shall be applicable upto 31.12.2021 in terms of Gazette notification No. S.O. 2347 dated 16.06.2021 or till further extended date, if any, notified by Ministry of MSME, Govt. of India. After this the modified provisions as notified vide circular 10/2021 shall be applicable.

In view of Ministry of MSME gazette notification no. S.O. 278(E) dated 19.01.2022, the said date has been further extended from 31.12.2021 to 31.03.2022.

Work centres and all concerned will continue pursuing and encouraging registration of maximum number of business partners on Udyam Portal in terms of Gazette notification No. S.O. 2119(E) dated 26.06.2020 (as amended). The dealing officers shall verify Udyam Certificate from Govt. Udyam portal and update MSE status in SAP as envisaged in circular no. 10/2021.

Above guidelines should be meticulously followed by all concerned.
