### Circular No. 11/2022-cum-IMMM Amendment No. 73

No: DLI/CORP-MM/PMC/2022/ 946019

**Sub: Para 1.3.2 of Integrated MM Manual pertaining to Centralized procurement of Items by ONSG, Vadodara.**

Reference is invited to Para 1.3.2 of IMM Manual, wherein list of items/services to be procured/hired centrally by ONSG, Vadodara has been detailed, and against Sl. No.41 of the list, 'OEM Spares' is mentioned. Reference is also invited to PMC Circular 15/2020, wherein inter-alia it is mentioned that "orders for supply of spares against IMPETUS RC to be placed by work center only. However, imported OEM spares for Drilling Services, other than those handled by IMPETUS will be dealt by ONSG." Further, vide PMC Circular 29/2021, it was clarified that OEM Spares of Drilling & Well Services for Onshore operations, which are not covered under IMPETUS RC, are to be procured by ONSG, Vadodara as per para 1.3.2 of IMM Manual. However, all OEM spares for WSS Equipment of WSS, Ahmedabad, which are not covered under IMPETUS RC, shall be procured by MM, Ahmedabad.

In order to have streamlined and effective procurement of OEM Spares, it is clarified as under:

- i) Orders for supply of spares against IMPETUS RC shall be placed by respective work center.
- ii) OEM spares for Well Services, WSS and Indigenous OEM spares for Drilling Services, which are not covered under IMPETUS RC, shall also be procured by respective work center.
- iii) OEM spares for WSS Equipment of WSS, Ahmedabad, which are not covered under IMPETUS RC, shall be procured by MM, Ahmedabad
- iv) Imported OEM spares for Drilling Services, which are not covered under IMPETUS RC, shall be procured by ONSG.

Accordingly, para 1.3.2 of IMM Manual is modified as under:
