Sub: Emphasis on use of Government e-Marketplace (GeM) portal for purchase in ONGC.

Government of India (GOI) has created a one stop Government e-Marketplace (GeM) to facilitate on-line procurement of Goods & Services required by various Government departments/organizations/PSUs. Detailed guidelines for making purchases through GeM were notified vide Circular No. 52/2018 dated 04.10.2018. This was followed by Circular no. 56/2018 dated 27.10.2018 wherein an illustrative list of items available in GeM was enclosed.

Recently, Government of India has been laying emphasis on the use of Government e-Marketplace (GeM) portal and has also stressed upon the need for enhancement in procurement of Goods & Services required by Oil PSUs through GeM. MoPNG, vide its correspondence No. D-19021/2/2017-Admn dated 04.09.2019, has circulated a list of products and services of common use available on GeM, (Attached at Annexure-1), as per which these items are to be procured through GeM only.

It is once again reiterated that all efforts should be made to procure these Goods and Services only through GeM. Due care be taken to ensure that the Services available on GeM meet the required scope of work of ONGC.
