

RWAs urge CM to reduce VAT on fuel prices in Delhi

NEW DELHI: Days after dealers of petrol and diesel stations in Delhi announced to go on strike on October 22, a number of residents' welfare associations (RWAs) and civil society groups have come out in support and urged chief minister Arvind Kejriwal to reduce VAT on fuels.

Raising the issue of air pollution, some residents said the steep petrol prices in Delhi have forced them to buy low quality and polluting variant of the fuel from neighbouring cities. "Due to price difference of about Rs 2-3/litre, Delhiites living near borders are being forced to buy fuel from neighbouring states of Uttar Pradesh and Harvana which still is on Bharat Standard (BS) IV as compared to less polluting BS VI, which is available only in Delhi," Manish Chawla, a resident of Anand Vihar, said.

The Central government had slashed the rate of petrol and diesel by ₹2.50 per litre on October 4. This was followed by reduction of Value Added Tax (VAT) by various states, including Haryana and UP.

The Delhi Petrol Dealers Association (DPDA) has already decided to observe a closure on October 22 to protest the fuel prices. "If the difference in prices continues, there will be a drop of 50% in sale of diesel in Delhi and 25% in petrol in this quarter," said a member of DPDA.

Residents also pointed out how inadequate public transport network adds to the problem.



Oil India Limited makes two Hydrocarbon discoveries

Oil India Limited (OIL) has made two Hydrocarbon discoveries in Dibrugarh and Tinsukia district in the Upper Assam Basin during the second quarter (Q2) of the financial year 2018-19, in the wells West Lohali -1 and Dhakuwal-1. The well West Lohali-1 encountered one sand in Barail formation of Oligocene age. On testing, a 13 m Barail sand at a depth of 2,357 m, produced gas at the rate of 1,15,000 scmd. The well Dhakuwal-1 encountered two zones in LK+TH formation of Eocene age. On testing, a 15 m LK+TH sand at a depth of 3,875 m, produced gas at the rate of 1,00,000 scmd with 22 m³/d condensate.

Fuel excise duty cut 'credit negative' for India: Moody's

The excise duty cut on petrol and diesel is credit negative for India as it will reduce government revenue and increase fiscal deficit by 0.1 per cent to 3.4 per cent of GDP in the year ending March 2019, according to Moody's Investors Service. Also, the earning of public sector oil marketing companies (OMCs) would be "negatively affected" as they also absorbed Rs 1 per litre cut in their pricing, Moody's said.

The government had recently cut excise duty on petrol and diesel by Rs 1.5 a litre, sacrificing Rs 10,500 crore revenue in the current financial year.

"Overall, excise duty cuts are credit negative because they will reduce government revenue collection," it said. PTI



Clean Ganga: Just 25% of ₹20,000 cr released, no takers for CSR projects

While the government and many others profess commitment to the holy Ganga — keeping it "aviral and nimal" as campaigners like late GD Agarwal had been demanding — the government records narrate a different tale.

According to documents accessed under the Right to Information (RTI) by Roparbased activist Dinesh Chadha from the Ministry of Water resources, River Development and Ganga Rejuvenation, the Narendra Modi-led government released just about Rs 5,500 crore from 2013-2014 till June 30, 2018, for the National Mission for Clean Ganga (NMCG).

The government has promised to spend about Rs 20,000 crore for rejuvenation of the national river. The apathy towards Ganga gets further highlighted with another piece of information accessed by Chadha. The NMCG through its website had requested companies to serve the holy river by adopting CSR projects — ghat construction, cleaning of ghat,

IEC activities, bio-remediation of nalas and drains Ganga gram, crematoria, river surface cleaning using trash skimmer, solid waste management and tree plantation, etc —but as per the RTI, no company adopted any project, at least till July 30, 2018.

The list of individual contributors to the CGF does not include any of the "politicians who play politics on the name of Ganga", says Chadha. But with a contribution of

Meanwhile, around Rs 255 crore was collected by the CGF under the CSR till July 27, 2018. Though the document do not reveal how much of it was actually utilised, a Parliament reply in March stated that till January 31, 2018, the Rs 221.75 crore collected under the head had

remained unutilised.

In March, Minister of State for Water Resources Satyapal Singh told Parliament that "as on date no fund has been utlised by the Namami Mission for Clean Ganga under the CGF". Gujarat contributed Rs 8.36 crore to the CGF between March 13, 2015, and March 31, 2016; 145 NRIs contributed Rs 24.92 crore and 224 private companies Rs 25.76, with Bank of America contributing the highest Rs 4 crore.



RWAs urge reduction in VAT on petrol, diesel

Several resident welfare associations and civil society groups in Delhi have urged Chief Minister Arvind Kejriwal to reduce VAT on petrol and diesel in the city, claiming the residents were suffering due to price hike.

The central government had slashed the rate of petrol and diesel by Rs 2.50 per litre on October 4, VK Arora, the convenor of Delhi Residents Forum said.

This was followed by reduction of Value Added Tax (VAT) by various states including neighbouring Haryana and Uttar Pradesh bringing relief to their residents.

"We urge the Delhi government to reduce VAT on petrol and diesel in the national capital and bring the fuel prices down," Arora said.

With the festival season on, secretary of Mahila Pragatisheel Association (MPA) Ritu Bhatia said the residents

are being forced to use private vehicles in the capital due to lack of affordable and efficient public transport.

"Due to price difference of about Rs 2 to 3 in fuel prices with Haryana and Uttar Pradesh, Delhiites living near borders are being forced to buy fuel from neighbouring states which is Bharat Standard (BS) IV as compared to less polluting BS VI in Delhi," Manish Chawla, a resident of Anand Vihar said.
