Sub: Purchase preference Policy (linked with Local Content) (PP-LC).

Reference is invited to Circular No. 19/2017 dated 16.05.2017 & 33/2018 dated 05.07.2018 whereby detailed guidelines, tender and contract conditions pertaining to Purchase preference Policy (linked with Local Content)(PP-LC) and clarifications thereon respectively were notified for compliance by all concerned.

In continuation to above, as per the decision taken in EPC meeting (14/2018) held on 21.06.2018 (UCN 777), the existing provisions shall be supplemented with the following:

“In case of a foreign bidder, certificate (with regard to the fulfillment of minimum mandatory local content requirement) from Statuary Auditor of their office in India is required to be submitted. In case office does not exists or is not required to appoint Statuary Auditors, certificate from a practicing Chartered Accountant in India shall be acceptable.”

In accordance with aforesaid directive of EPC, standard tender/contract conditions for procurement of goods (ICB), Services (ICB) stand modified as per Appendix-1. The other tender/contract documents where subject policy is applicable, shall also be modified accordingly.

Above guidelines should be meticulously followed by all concerned.
