Sub: Review of the provisions of Integrated MM Manual pertaining to competent authority for rejection of bid after price bid opening for non-compliance of BEC and tender conditions.

EPC, in its meeting (11/2018) held on 10.05.2018 has reviewed the provisions pertaining to competent authority for rejection of bid after price bid opening for non-compliance of BEC and tender conditions.

EPC opined that in case of two bid system, bids are also liable to be rejected post-price bid opening, due to non-compliance of various BEC and tender conditions such as non-meeting of financial criteria, not meeting the limits of mobilization charges etc. EPC decided that in line with the powers devolved for shortlisting of the bids vide para-11.1.4 of IMMM, Director (concerned) shall be the competent authority, for approving rejection of bids after price bid opening for non-compliance of BEC and tender conditions, in EPC level cases.

In accordance with the decisions taken in the aforesaid meeting of EPC, relevant provisions of Integrated MM Manual stand modified as per Annexure-I.
