**OFFICE ORDER**

**Re : Banning of Business Dealings with M/s. Ganesh Benzoplast Ltd., Mumbai**

- I) WHEREAS, ONGC Uran Plant, Uran floated an Open Indigenous e-tender No. MR/URAN/MM/SERV/HIRING-TANK/14/2012-13, SAP tender no. UA6KC12002, for "Hiring of Services for Additional Storage of Crude Oil & Pumping of Oil for tankers loading at JNPT" under two bid system (hereinafter referred to as the 'said Tender').
- II) And WHEREAS, against the said Tender, M/s. Ganesh Benzoplast Ltd., Mumbai. (Vendor Code: 804908) had submitted its offer. While evaluating un-priced Techno-commercial bids and the reply submitted by them against ONGC's techno-commercial queries it was found by the tender committee that some of the documents submitted by M/s. Ganesh Benzoplast Ltd., Mumbai, in support of the bid were tampered with and forged. Their bid was accordingly rejected
- III) And whereas, ONGC initiated enquiry proceedings for banning of business dealings with M/s. Ganesh Benzoplast Ltd., Mumbai for submission of forged documents.
- IV) And whereas, notice dated 11.11.2013 was issued by Enquiry Officer calling upon M/s. Ganesh Benzoplast Ltd., Mumbai to present its case and submit original documents/clarifications. The representative of M/s. Ganesh Benzoplast Ltd., Mumbai was also granted personal hearing on 27.11.13 and 2.12.13
- V) And whereas M/s. Ganesh Benzoplast Ltd., Mumbai have also submitted their written reply dated nil.
- VI) And whereas on detailed inquiry and after prudent examination of the case, ONGC has arrived at the conclusion that M/s. Ganesh Benzoplast Ltd., Mumbai has deliberately submitted tampered/ forged documents against above tender. Hence ONGC has decided to stop any further business dealings with M/s. Ganesh Benzoplast Ltd., Mumbai for participation in future tenders on ONGC whatsoever, for a period of 2 (two) years from the date of issue of this order
