#### I. COMPANY PROFILE

ONGC is a schedule –'A' / Maharatna CPSE in Crude Oil sector under the administrative control of Ministry of Petroleum and Natural Gas.

Its Registered and Corporate offices are at New Delhi and Dehradun, Uttarakhand respectively.

The authorized and paid up capital of the Company were Rs.15,000 crore and Rs. 4277.77 crore respectively as on March 31, 2016.

The shareholding of the Government of India in the company is 68.94%.

#### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

The Director(Onshore) is a member of the Board of Directors and reports to Chairman and Managing Director. He is overall incharge of the Onshore Production Assets Broad responsibility includes:-

- 8. Facilitate new technology absorption and availability of operational inputs/facilities from institutes.
- 9 Interact with other Directors/Top Managers for optimal utilization of ONGC resources.

## 3. QUALIFICATION:

The applicant should be an Engineering graduate with good academic record from a recognized University/Institution.

Applicants holding Post Graduate degree in Engineering/Management/ relevant Sciences of Geo-Science will have added advantage.

#### 4. EXPERIENCE:

The applicant should have atleast five years cumulative experience at a senior level of management during the last ten years in an organization of repute in petroleum sector.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

#### 3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
