Sub: Age of equipment to be supplied.

Reference is invited to the provisions under *Warranties and Guarantees: Material and Workmanship clause* appearing in standard Booklets for procurement of goods, which *inter alia* stipulates that SUPPLIER shall fully warrant that all the stores, EQUIPMENT and components supplied under the ORDER shall be new and of first quality according to the specifications and shall be free from defects (even concealed fault, deficiency in design, Materials and Workmanship).

EPC, in its meeting (29/2016) held on 29.09.2016 reviewed the above provisions and decided that above provisions should also stipulate that in case of supply of finished product/ item/ equipment/ material, the finished product/ item/ equipment/ material shall in no case be of a date of manufacture older than one year from the date of its shipment/despatch. The age norms for goods / equipment shall be applied uniformly for purchase of indigenous as well as imported material and this criteria should be incorporated in domestic as well as in ICB tenders.

In accordance with the aforesaid decision of EPC, relevant provisions of standard booklets for procurement of goods stand modified as per Appendix-1. Similar modifications should also be carried out in other tender documents including LSTK.

Further, it shall be ensured by all concerned that above conditions are made part of the NOAs, besides specifying the same in the contract scope of work of TPI engaged for inspection of imported equipment.

Above guidelines should be meticulously followed by all concerned.
