### 3. Eligibility conditions:

- A. **Qualifications**: Prescribed qualification as mentioned above with a minimum of 50 % marks in qualifying exams.
- B. <u>Age</u>: The candidate should have attained the age of 14 years and should not have attained the age of 21 Years as on 15.03.2017.
- C. <u>Minimum Physical Standards</u>: As prescribed in the apprenticeship Rules 1992 clause 4 and amendments thereof if any.
- D. <u>Previous Training</u>: Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship Act 1961 in any Government or Public Sector or Private industrial organization are not eligible to apply
- E. The applicant should not have undergone Apprenticeship earlier or pursuing Apprenticeship training as per the Apprentices Act, 1961/1973 as amended from time to time.
- F. The applicant should not have completed three years after passing of the qualifying exam as on 31.07.2017.
- 4. **Stipend**: Monthly stipend will be paid as per the prescribed rates governed by apprenticeship act.
- 5. Selection Procedure: Shortlisting of candidates will be done based on the percentage of marks obtained in the basic prescribed qualifications as applicable to the respective trade.
- 6. **Boarding / Lodging / Travel Expenses:** No Boarding / Lodging and Travel expenses are admissible.
