- A. QUALIFICATIONS: Prescribed qualification as mentioned above with a minimum of 50% marks in qualifying exams.
- B. AGE: The candidate should have attained the age of 14 years and should not have attained the age of 21 years as on 01-03-2017.
- C. MINIMUM PHYSICAL STANDARDS: As prescribed in the Apprenticeship Rule 1992, clause 4 and amendments thereof if any.
- D. PREVIOUS TRAINING: Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship Act 1961 in any Government or Public Sector or Private industrial organisation are not eligible to apply.
- **5. STIPEND:** Monthly stipend will be paid as per the prescribed rates governed by Apprenticeship Act.
- **6. SELECTION PROCEDURE:** Shortlisting of candidates will be done based on the percentage of marks obtained in the basic prescribed qualifications as applicable to the respective trade.
- 7. TRAVEL EXPENSES: No travel expenses are admissible.
- **8. BOARDING / LODGING:** No BOARDING or LODGING expenses are admissible.

- **11. MEDICAL FITNESS:** Candidates have to submit Medical Fitness Certificate obtained from a Medical Officer not below the rank of Assistant Surgeon (Gazetted).
