- 2. Candidates are required to bring with them 2 recent passport size photograph, all original certificates (class X onwards) and self-attested photocopies of the certificates and report to Chief Manager (HR)-Recruitment as per date, time and venue mentioned above.
- 3. Candidates will be provisionally allowed to appear in the interview subject to fulfilment of all other eligibility criteria of essential qualification, age, caste certificate, etc., therefore, the candidates may kindly ensure that they are fulfilling all the requisite criteria prior to

- coming for personal interview, failing which, their candidature is liable to be rejected/cancelled.
- 4. Caste certificate for OBC category candidate(s) should be in prescribed format meant for employment in Central Govt/ Central Public Sector Undertakings. Latest non-creamy layer certificate in respect of OBC candidates should be produced, if applicable.

6. General Instructions:

- **6.1.** Engagement is purely temporary, on contract basis, and can be terminated at any time by giving one month notice, by either side.
- **6.2.** No claim for regular employment in ONGC, by virtue of this contractual engagement, shall be entertained at any stage.
- **6.3.** Selected candidates will be paid consolidated monthly remuneration as mentioned above.
- **6.4.** Engagement on contract will be subject to medical fitness.
- **6.5.** Selected candidates shall be required to sign a contract agreement as per the terms and conditions of ONGC.
- **6.6.** Contract tenure will commence from the date of joining.
- **6.7.** The contract shall end on expiry of the prescribed period and no separate notice shall be required to be given.
- **6.8.** Candidature/contract of candidate(s) submitting false certificates or suppression/ submission of incorrect information shall be liable for termination/ disqualification/ rejection at any stage.
- **6.9.** Only Indian nationals need apply.
- **6.10.** No TA/DA shall be paid for attending written test/ interview.
- **6.11.** Interested candidates fulfilling the above conditions should bring all original certificates including No Objection Certificate (NOC) from existing employer (if any), two recent passport size photographs.
- **6.12.** The qualifications for the above posts should be from recognized university/ institution.
- **6.13.** The selected candidates are to be posted in Dehradun.
