Attested photocopy of certificates such as 10th Mark Sheet for Date of Birth, Airline Transport Pilot License(H) or Commercial Helicopter Pilot License (H), on twin engine helicopter with IR(Instrument Rating), flying experience certificate and minimum 10 years managerial experience / Operations in-charge in aviation industry etc, are required to be attached with the application.
- 3. The post applied for should be super-scribed as "DGM (Logistics)-Aviation " on the top center of the envelope.
