UDAAN J&K- GENERAL INFORMATION AND INSTRUCTIONS:

Under the scheme titled UDAAN J&K, launched by Government of India, Graduate/Post-graduate engineers from disciplines namely Information technology, Computer Science, Electrical Engineering and Electronics and Communications are to be trained for a period of 90 days and exposed to employment opportunities in various companies, as facilitated by Chandigarh Group of Colleges (CGC), Gharuan, Mohali, Punjab. Placement of the trained engineers will essentially depend on the performance of the candidates during training and meeting other eligibility criteria as may be specified by the recruiting organisations. Young engineers from J&K are invited to apply and avail this unique opportunity.

MINIMUM ELIGIBILITY CRITERIA

- Candidates having domicile of Jammu and Kashmir only are eligible.
- Upper age limit is 28 years, as on the date of walk-in-interview,

 Computer Science, Electrical Engineering and Electronics and Communications with minimum 60% marks only can apply. Final year students of above branches may also apply subject to getting 60% marks in degree and if shortlisted, they will be considered for subsequent batches after declaration of their final result.
