Auto fuels at a new peak with another hike

NEW DELHI: Auto fuels soared to another record levels on Friday with petrol in Delhi surging to ₹101.89 per litre and diesel at ₹90.17 as state-run retailers raised their rates by 25 paise and 30 paise, respectively, even as international oil market soften on prospects of supply ease by the oil cartel.

Recent spike in pump prices of petrol and diesel started last week due to a spike in international oil prices as benchmark Brent crude breached \$80 a barrel, a three-year high, on Tuesday due to rising demand and supply concerns. Subsequently, Brent retreated and on Friday trade it fell to \$77.55 per barrel on the prospect of supply ease by the Organisation of the Petroleum Exporting Countries and its allies, including Russia (together known as OPEC+), which is meeting on Monday.

The previous record rates of petrol and diesel were reported in mid-July at ₹101.84 per litre and ₹89.87, respectively, when benchmark Brent crude was around \$73 a barrel. After staying at that level for about a month, the two fuels saw gradual rate reductions—petrol by 65 paise per litre and diesel by ₹1.25—between mid-August and early September after Brent soften to \$68.23 per barrel on



Sri Ganganagar in Rajasthan saw petrol price rise to ₹113.73 a litre and diesel to ₹103.9 per litre.

August 18. The recent hike in pump prices started from last Sunday. After keeping fuel rates frozen for 18 days since September 6, oil companies first started raising diesel price in small doses from September 24. Northward movement of petrol prices, however, started a bit late, from September 28.

While diesel crossed ₹90 a litre for the first time in Delhi, it has already crossed ₹100 mark in Rajasthan's Sri Ganganagar (₹103.9 per litre). While the benchmark automobile fuel prices for the country are set by the Indian Oil Corp. Ltd (IOCL) in Delhi, retail prices vary from place to place due to local levies. Prices are also moving up

prices are also moving up because the rupee is depreciating against the dollar, which makes imports costlier, the executive said. India imports more than 80% of crude oil it processes and pays in US dollars.

City gas distribution players Indraprastha Gas Ltd and Mahanagar Gas Ltd are set to increase prices of compressed natural gas (CNG) and piped natural gas (PNG) for households following a steep 62% hike in domestic natural gas prices for Oct-Mar, sources with direct knowledge of the matter told Informist.

The price increases by the two city gas players are expected within a day or two and both the companies are currently in the process of finalising the quantum of the price hikes.

Sources, however, declined to divulge the likely increases in prices of CNG and domestic piped gas.

Aviation turbine fuel (ATF) or jet fuel price on Friday was hiked by a steep 5.8% in line with rise in international oil prices.

ATF price in Delhi was increased by Rs 3,972.94 per kilolitre, or 5.79%, to Rs 72,582.16 per kl, according to a price notification of state-owned fuel retailers.

Jet fuel prices are revised every fortnight in line with international benchmarks.

In Mumbai, aviation turbine fuel now costs Rs 70,880.33 per kl.

Rates differ from state to state depending on local taxes.

The hike follows international oil prices rising to a near three-year high on return of demand.

Petrol at all-time high, diesel crosses Rs 100-mark

Petrol and diesel price soared to an all-time high across the country on Friday after rates were hiked again by 25 paise and 30 paise a litre, respectively.

The price of petrol in Delhi rose it its highest ever level of Rs 101.89 a litre and to Rs 107.95 in Mumbai, according to a price notification of state-owned fuel retailers. Diesel rates too touched a record high of Rs 90.17 in Delhi and Rs 97.84 in Mumbai.

Prices differ from state to state depending on the incidence of local taxes. The third increase in its rates this week has sent petrol prices above Rs 100 in most major

cities of the country.

Sept Petrol Sales Race Past Pre-Covid Level, Diesel Down



NEW DELHI The demand for petrol surged 9% above the pre-pandemic level in Sept while that for diesel stayed 6.5% lower, in a sign of

divergent recovery paths the two fuels have taken following the easing of Covid-19 restrictions. Petrol sales rose 6.6% year-on-year in September while diesel rose barely 1% over last year, as per the preliminary sales data from state-run oil companies that control nearly 90% of the fuel retail market. Global Brands entering India to Make EVs: Gadkari

Global brands entering India to make EVs: Gadkari

FE BUREAU Pune, October 1

NITIN GADKARI, UNION minister for road transport and highways, on Friday, said the production linked incentive (PLI) scheme for the automobile sector would lead to fresh investments of ₹42,500 crore in the automotive industry and create 7.5 lakh additional jobs. The minister said several global brands are entering India to produce electric vehicles at a mass scale.

There was a massive response in the domestic market for electric scooters from startups with a company recently setting a record of one lakh units booked worth ₹1,100 crore, he said. The minister said electric two-wheelersales in the country was at 13,335 units during July 2021, which was a massive 229% month-on-month jump and an 836% year-on-year leap in registrations, which was extremely encouraging.

He expected people to slowly move away from diesel and petrol vehicles. Gadkari was speaking at the annual Symposium on International Automo-



tive Technology (SIAT) 2021 being organized virtually by the Automotive Research Association of India with SAE India on 'Future Trends for Mobility'.

In the case of lithium-ion batteries, the country can generate 81% of the value in India and there is a need to work alternatives such as aluminium ion, zinc ion sodiumion batteries. He urged the Automotive Research Association of India to work on battery alternatives and join hands with ISRO, DRDO and IITs that were working on indigenous development of low-cost battery technology. To support the EV ecosystem, the NHAI was developing electric vehicle charging infrastructure along the highway to promote the use of EVs, he said ate Win

Simultaneously the country

also needs to work on alterna tive fuels such as ethanol, methanol, bio CNG, LNG, S-CNG and green hydrogen fuel, he suggested. The government was planning to introduce flexfuel vehicles which allow operation of the vehicle on 100% ethanol and petrol. The flex engine-based vehicles were running in the US, Brazil and Canada with 83% of the light vehicles in Brazil running with flex engines, Gadkari said. He wanted India to move on a similar path. Brazil was also using ethanol for aviation and India too should looking at using bioethanol for aviation would be a game-changer, he said.

Gadkari said there was a need to find appropriate and affordable technology for the generation, transportation and storage of green Hydrogen. MoRTH had already notified standards for emission and safety of hydrogen. He urged the auto industry to tap the expertise of ISRO and IOCL in handling hydrogen. He stressed developing low-cost electrolysers which could be a game-changer in Hydrogen fuel adoption.

Ethanol consumption set to rise as govt looks to increase rate of fuel blending

FOOD SECRETARY SUDHAN-SHU Pandey on Friday said the country's fuel ethanol consumption is set to rise and the government is targeting the implementation of motor fuel blending at the rate of E20 (20:80 ethanol: gasoline) by the year 2024. Motor fuel blending of 20% will become mandatory from 2025, he said. While delivering the inau-

gural addressing an event organised by the Indian Sugar Mills Association (Isma), he said that the government has come out with regulations for the automobile sector according to which, E10 (10:90 ethanol: gasoline) has already been allowed.

By 2025, the 20% fuel blending target shall be achieved by using 17 million tonne of foodgrains, which is also surplus. This move will help farmers, industry and the environment.

"Currently the country has 90 million tonne of foodstock

in public stock holding. Many countries thought that stock is burdening the market. But during the Covid-19 pandemic, almost 60 million tonne of foodgrains were distributed free of cost to 800 million people. This helped the country fight Covid-19 pandemic in an effective way. Now India will be moving towards E20 target by using about 17 million tonne of foodgrains for ethanol production," he said. The country also intends to move towards flexifuel engines so that higher level of blending is permitted in the country, he declared. Pandey said that the automobile industry has been invited to bring in technology which is already available globally so that surplus foodgrains and sugarcane are used, providing relief to all stakeholders in the entire eco system.

Outlining India's journey towards the use of ethanol, he said that a policy was made to divert excess production to ethanol production. "The industry came forward in a big way and last year 2 million tonne of sugar were diverted towards ethanol production. This year we hope to divert 3.5 million tonne and next year 6 million tonne of sugar will be reduced and diverted towards ethanol production.

"India started this journey very late and the country was not sure about achieving a balance between sugar and ethanol. With our own consumption of 26 million tonne, we were producing 40-45 lakh tonne of surplus sugar every year," he pointed out. With sugar prices remaining depressed, the impact was felt by farmers with delayed payments and mounting arrears.

Abhinash Verma, director general, Isma, stated that India has become a surplus sugar producer in the last 10 years. The country is expected to produce 31 million tonne of sugar in the 2021-22 season with an estimated sugar consumption of 26.5 million tonne and exports of 6 million tonne, he said. The closing balance as on September 30, is 7 million tonne, he added.

To reduce surplus sugar, mills are diverting to production of ethanol and opting for exports, he said. With incentives coming from the government, the industry is targeting the production of 14 billion litres of ethanol by 2025 from 3.5 billion litres of annual capacity in 2018. The target is to divert 6 million tonne of surplus to ethanol by 2025, he said.

India's fuel and electricity consumption grew at a slower pace in September compared with August, government data showed on Friday, despite a recovery in factory activity.

Sale of gasoil, which accounts for about two-fifths of India's refined fuel demand, by state retailers rose 0.79 per cent in September, preliminary government data showed. Gasoil sales rose 16 per cent in August compared with last year.

Electricity consumption rose 0.8 per cent in 17.1 per cent growth in August, September, compared with data from federal grid regula-

India's factory activity improved last month as a recovery in the economy from the pandemic-induced slump boosted demand and output, a private survey showed on Friday.

Oil ministry to seek nod to go beyond Budgeted target

New Delhi, 1 October

The Ministry of Petroleum and Natural Gas has got more than 10 million applications for cooking gas connections under the second leg of the Pradhan Mantri Ujjwala Yojana (PMUY 2.0). With this, the target for disbursing 10 million new connections set in the Budget 2021 has been breached.

"We will seek post-facto approvals for disbursing connections in excess of the target. No eligible beneficiary will be denied a connection," an oil ministry official told *Business Standard*.

In her Budget 2021 speech, Finance Minister Nirmala Sitharaman had said, "Ujjwala Scheme which has benefited 80 million households will be extended to cover 10 million more beneficiaries."

After that PMUY 2.0 was launched, with a focus on giving connections to migrant families that find it harder to furnish proof of address documents.

To make this leg of the programme even more affordable, the first LPG cylinder refill and hotplate (amounting to around ₹1,800 for both) is free. This is in addition to the ₹1,600 upfront amount that is waived for PMUY 2.0 beneficiaries.

A flagship scheme of the government, PMUY was launched to make Liquefied Petroleum Gas (LPG) available to the rural and deprived households. These lower-income families were

Since these connections were targeted for lowerincome households, they were offered without an upfront cost being borne by the beneficiary. This amount

was instead loaned by oil companies who then recovered it from the subsidy which was accrued on subsequent LPG refills that beneficiaries bought at full price. Sensing that PMUY beneficiaries were unable to bear the cost of LPG cylinders at full price, the government decided that oil companies should forego the recovery of these interest free loans. The PMUY target was

The PMUY target was achieved on September 7, 2019, when Modi handed over the 80 millionth connection in Aurangabad, Maharashtra. According to official data, over 83 million connections have been disbursed under the first phase of PMUY till date.

This led to an increase in India's LPG coverage from 62 per cent on May 1, 2016, to 99.8 per cent as on April 1, 2021. The gap is expected to be filled with PMUY 2.0.

As of September 15, the highest number of PMUY 2.0 connections have been disbursed in Bihar (605,000), while West Bengal (334,000) comes second and Gujarat (281,000) third.

Almost two million tonnes (MT) of sugar were diverted for ethanol production during the last sugar season (October 2020 to September 2021), Sudhanshu Pandey, Food Secretary, said at a webinar on sugar output on Friday.

During the current season, which started on Friday, about 3.5 MT of sugar are expected to be used for ethanol production in the country.

"[The] ethanol journey has just begun. And, we look forward to new technological interventions in future, and align our policies and programmes in a manner that we make the best of



these value chains and enrich all stakeholders... and also help economies not only in India but globally to prosper," he said.

Abinash Verma, Director General of the Indian Sugar Mills Association, said the opening stock for the current sugar season is 8.5 MT and production is estimated to be 31 MT. Exports would account for close to six million tonnes.




