Circular No. 21/2021-cum- Integrated MM Manual No. 66//2021-Cum-BL Amendment No. 01/127 and 02/102

Sub: Classification of Micro, Small enterprises (MSE) and Udyam Registration

Reference is invited to circular No. 10/2021 dated 06.04.2021, wherein modified tender condition and IMM manual provisions in respect to MSEs were modified on the basis of Gazette notification no. S.O. 2119(E) dated 26.06.2020 issued by Ministry of Micro, Small and Medium Enterprises.

As per said notification, all existing enterprises have to register at Udyam Registration portal and the existing enterprises registered prior to 30th June, 2020, would continue to be valid only for a period up to the 31st March, 2021.

Vide gazette notification no. S.O. 2347(E) dated 16.06.2021, Ministry of MSME has extended the date upto which registration of existing enterprises registered prior to 30th June 2020, would continue to be valid, from 31st March, 2021 to 31st December, 2021 (Annexure-I)

In view of above, provisions of Integrated MM Manual, Standard Tender/Contract Conditions and BEC modified vide Circular 10/2021 dated 06.04.2021 stands reinstated as existing prior to Circular 10/2021 and such reinstated provisions shall be applicable upto 31.12.2021 in terms of Gazette notification no. S.O. 2347(E) dated 16.06.2021 or till further extended date, if any, notified by Ministry of MSME, Govt of India. After this the Modified provisions as notified vide circular 10/2021 shall be applicable.

Work centres and all concerned will continue pursuing and encouraging registration of maximum number of business partners on Udyam Portal. The dealing officers shall update MSE status of vendors as per instructions in circular 10/2021.

Above guidelines should be meticulously followed by all concerned.
