Sub: Procedure to be followed while seeking relaxation for Global Tender Enquiry (GTE) for Tenders upto Rs 200 Crore.

Reference is invited to PMC Circular Nos. 40/2020 dated 28.08.2020, 55/2020 dated 23.11.2020 and 20/2021 dated 23.07.2021, wherein guidelines were issued for approving relaxation for inviting Global Tender Enquiry for tenders upto Rs.200 Crore.

In this regard, DPIIT, Ministry of Commerce and Industry, vide O.M. No. P-45021/31/2021-PP (BE-II)-Part-I (E-53204) dated 01.11.2022, has forwarded the Cabinet Secretariat's ID Note No. 213/2/1/2020-CA.IV (Vol.XVII) issued on 21.10.2022 (Copy of aforesaid O.M. is enclosed herewith for ready reference), intimating that the GTE proposals should categorically show following information:

- i) Total Lead time (in months) for the tendering process and supply respectively once the approval is accorded for procurement.
- ii) The financial year for which the proposed item is procured.

In view of the above, for the items/services for which proposal is submitted for seeking relaxation to invite Global Tender Enquiry, the proposal should also contain details as brought out at (i) & (ii) above in addition to details mentioned in Circular No. 20/2021 dated 23.07.2021.

Above guidelines should be meticulously followed by all concerned.
