Madam/Sir,

The Company has received Notices from Stock Exchanges, BSE Limited and National Stock Exchange of India Limited, both dated 21.11.2023 levying fine of ₹5,42,800/- each for non- compliance under Regulation 17(1) of SEBI (LODR) Regulations, 2015 w.r.t the composition of Board.

In this regard, information under Regulation 30 read with Schedule III of SEBI (LODR) Regulations, 2015, is enclosed.

It is informed that ONGC is a Government Company and power of appointment of Directors (including Independent Directors) is vested with the Government of India (GoI) as per its Articles of Association. The requirement for appointment of additional Independent Director was submitted to the Government of India (GoI) vide letters dated 08.05.2023 and 25.10.2023. The copy of said letters were also submitted to Stock Exchanges.

It may be noted that the said non-compliance with regard to the composition of the Board was neither due to negligence/ default by the Company nor within the control of the management of the Company and constant efforts are being made to meet the compliance requirements. Gol has been requested for nomination of requisite number of Independent Directors on the Board of the Company.

Considering the above position, both the exchanges have been requested to waive-off the above mentioned fine levied on the Company.
