No. 3 and HSN-2915 & 'Cesium Formate' at SI. No. 14. Copy of aforesaid Circular is attached herewith for ready reference.

1. Reference is invited to para-2 of our Circular No. DLH/Indirect Tax/Circular/43/2021-22/03 dated 03.02.2022 wherein it was stated that certain proposals of the Finance Bill, 2022-23 would be made effective from such date as may be notified by the Govt. Accordingly, such amendments as notified by the Govt. along with some other changes as relevant for ONGC operations are summarized below:

2. Specified Date for availing Input Tax Credit (ITC) and issuance of Credit Note:

Sec 16(4) of CGST Act has been amended vide GST Notification No. 18/2022-CGST dated 28.09.2022 whereby now the Input Tax Credit (ITC) has been allowed to be availed by 30th November following the end of the Financial Year to which the Invoice or Debit Note pertains or furnishing of the relevant annual return, whichever is earlier. It is pertinent to mention here that availability of ITC is subject to compliance of all other conditions as specified under GST Law (as amended from time to time).

Further, Sec 34(2) of CGST Act has also been amended vide aforesaid GST Notification whereby now a Credit Note can be issued by 30th November following the end of the Financial Year in which the supply was made or furnishing of the relevant annual return, whichever is earlier.

[Effective from 01.10.2022]

3. Amendment in List-33 of Customs Notification No. 50/2017-Cus (as amended):

Reference is also made to para- 1 of our aforesaid Circular dated 03.02.2022, whereby the amended list of specified goods (List-33) under Customs Notification No. 50/2017-Cus (as amended vide Notification No. 02/2022-Cus) was, *inter-alia*, provided at Annexure-I. Now, the Govt. vide Customs Notification No. 50/2022-Cus dated 27.09.2022 has further amended the said List-33 by inserting HSN-8481 at Sl. No. 3 and HSN-2915 & 'Cesium Formate' at Sl. No. 14. The revised updated List-33 is annexed herewith at *Annexure-I* wherein the changes have been highlighted.
