**Sub:** Banning order for banning of business dealings with M/s Ventures Advertising Pvt Ltd, Mumbai (Vendor Code: 865215) for a period of one (01) year (from 18.11.2022 to 17.11.2023) on account of submission of false/ forged/ fabricated documents in the Tender No. X01AC21001.

**Ref:** Tender No. X01AC21001 for "EOI/ Tender for Empanelment with rate contract of Advertising Agencies for Corporate Communication jobs"

Dear Sir/ Mam,

- 1.0 WHEREAS, Tender No. X01AC21001 was invited by Delhi MM, ONGC Delhi (hereinafter referred to as the 'CORPORATION'), for "EOI/ Tender for Empanelment with rate contract of Advertising Agencies for Corporate Communication jobs"
- 2.0 AND WHEREAS, you (i.e, M/s VENTURES ADVERTISING PVT LTD, MUMBAI), herein after to be referred as 'firm') had participated in the said Tender vide bid dated 21.05.2021
- 3.0 AND WHEREAS, against the above referred clauses of said Tender, you along with your bid had submitted undertaking to the effect that all the documents/certificates/information submitted by them against the tender are genuine and in case any of the documents/certificates/information submitted by them is found to be false or forged, action as deemed fit may be initiated by ONGC at its sole discretion.
- 4.0 AND WHEREAS, a complaint dated 31.08.2021 was received by ONGC about an alleged fabricated document i.e., Work Completion Certificate as submitted by you against the tender issued by M/s Gail India Ltd (GAIL).
- 5.0 AND WHEREAS, the Work Completion Certificate submitted by you (M/s Ventures Advertising Pvt Ltd, Mumbai) was sent to Head -Corporate Communications, M/s Gail India Ltd (GAIL) for confirmation of veracity of the complaint and the authenticity of the said document i.e, work completion certificate.
- 6.0 AND WHEREAS, M/s Gail India Ltd (GAIL) have confirmed vide their mail dated 01.09.2021 that the said document i.e, work completion certificate as submitted by M/s Ventures is fabricated.
- 7.0 AND WHEREAS, ONGC initiated inquiry proceedings for banning of business dealings, as per the para 40.1 of Annexure-I, ITB of tender document (Tender No. X01AC21001) and appointed enquiry officer. Accordingly, a show cause notice dated 17.03.2022, was served by the enquiry officer, ONGC to let ONGC know the points/response of M/s Ventures Advertising Pvt Ltd, Mumbai in this



matter upon the allegations and why ONGC should not ban business dealing with it in view of the alleged forgery.

- 8.0 AND WHEREAS, M/s Ventures Advertising Pvt Ltd, Mumbai submitted their reply dated 13.04.2022 stating that the submission of said forged document was an act of disgruntled employee of M/s Ventures Advertising Pvt Ltd, Mumbai to get M/s Ventures blacklisted by ONGC. AND WHEREAS, a personal hearing was also given to M/s Ventures Advertising Pvt Ltd, Mumbai on 13th June, 2022. Accordingly, reply/response of said firm has been duly addressed/considered by the enquiry officer.
- 9.0 AND WHEREAS, considering the allegations upon M/s Ventures Advertising Pvt Ltd, Mumbai and their reply/response therein, evidently, M/s Ventures Advertising Pvt Ltd, Mumbai. has submitted fabricated documents in its bid while participating in the aforesaid tender and thus violated the tender clause 40.1
- 10.0 Accordingly, as per provisions under clause 40 of Annexure I - Instructions to Bidders (ITB) and clause 36 of Annexure II - General Contract Conditions of Tender No. X01AC21001, your firm i.e. M/s Ventures Advertising Pvt Ltd, Mumbai (Vendor Code: 865215) along with its allied concern, partner or associate or director or proprietor involved in any capacity etc. is being put on holiday. [i.e. neither any tender enquiry will be issued to you i.e. M/s Ventures Advertising Pvt Ltd, Mumbai by ONGC against any type of tender nor your offer will be considered by ONGC against any ongoing tender(s) where contract between ONGC and you i.e. M/s Ventures Advertising Pvt Ltd, Mumbai (as a bidder) has not been concluded] for a period of one (01) year from the date of issue of this letter i.e. from 18.11.2022 to 17.11.2023 on account of submission of false/ forged/ fabricated documents against Tender No. X01AC21001 for 'Empanelment with rate contract of Advertising Agencies for Corporate Communication jobs'.
