Following is the process steps to claim the outstanding unclaimed CPF amount pending with ONGC ECPF Trust, Dehradun (Uttarakhand):

Step-I	Self /Nominee/ family member shall approach to the office of Separated Employee Establishment /Incharge HR/ER Office of last place of posting to claim the outstanding CPF amount.
Step -II	Submit the following documents to Separated Employee Establishment / Incharge - HR/ER Office of last place of posting :  i) Duly filled in CPF Withdrawal Application Form No. CPF-SEP-01 ( <b>Annexure -2</b> ) ii) Indemnity Bond on Rs.100/- Non-judicial stamp paper ( <b>Annexure -3</b> ) iii) Life Certificate duly certified by competent authority in case of claiming self iv) Copy of Pan Card/ Bank Details viz. Passbook/ Cancelled Cheque
Step -III	In case of any enquiry, may kindly contact office of I/c Separated Employees Establishment / Incharge- HR/ER office /ONGC Welfare Trust at email id : <b>trustcare@ongc.co.in</b> or at Phone No. <b>0135-2793131</b>
