NEW DELHI Adani Total Gas Ltd (ATGL) on Thursday reported a 12% drop in its September quarter net profit as higher gas price hurt margins. Net profit of ₹139 crore in July-September compared with ₹159 crore profit a year back, the company said in a statement. Gas sales increased 9% to 191 million standard cubic metres, driven by a rise in CNG demand. Revenue was up 73% at ₹1,190 crore. But what hurt ATGL was cost of gas, which it converts into CNG for sale to automobiles and piped natural gas for household cooking and industrial needs, PTI

FM launches biggest coal mine auction; 141 blocks up for grabs

Finance Minister Nirmala Sitharaman on Thursday launched the sixth tranche of commercial coal mines auction, under which the government is offering 141 blocks across 11 States — the biggest auction so far of the key fuel for power generation.

The Coal Ministry has offered 133 blocks for auction, of which 71 are new mines and 62 are roll over from earlier tranches. Besides, eight blocks from the second attempt of the fifth round of commercial auctions have also been included.

'LANDMARK EVENT'

Emphasising that coal is an important asset for India's economic development, Sitharaman termed Thursday's auction a landmark event.

"Eleven States can directly benefit from today's (Thursday) auction. This will open up their capacities. The sixth tranche takes a very big step forward in releasing greater resources," she added.

Coal Minister Pralhad Joshi said that under commercial coal mining, India has auctioned 67 blocks so far, and some of them are set to start production this year. Madhya Pradesh has the highest number of 30 blocks, followed by Chhattisgarh with 28 and Odisha (27).

PRODUCTION TARGET

"This year (FY23), we are hoping for 5 million tonnes (mt), and next year, a minimum of 10-15 mt production will come from commercial coal mines," said Joshi.

The Minister acknow-

ledged that there was a shortage of around 12 mt of coal but commercial mines will fill a gap of 5 mt in FY23. Fuelled by the reforms in FY22, captive coal blocks have produced over 89 mt, which is a first, he added.

"All put together, total coal dispatch in 2014 was 572 mt, and in FY22, India achieved 817 mt.

"In the ongoing year (FY23), the total production put together, I am very confident, is going to be 900 mt, including of commercial, captive, abundant mines and Coal India," the Minister

With Delhi's Air Quality Index just short of enter-ing the "severe plus" category, a Central panel on Thursday directed authorities to ban the plying of four-wheeled diesel light motor vehicles in Delhi and adjoining NCR districts and the entry of trucks into the capital as part of anti-pollution measures under the final stage of the Graded Response Action Plan. However, BS-VI vehicles and those used for essential and emergency services have been exempted from the ban. The panel has also directed closure of all industries running on nonclean flues in the region, "even in areas which do not have PNG infrastructure and supply." The panel has left it to the Central and state governments to decide on permitting work from home. A day after registering a marginal improvement in air pollution, a thick layer of smog covered Delhi and its adjoining areas on Thursday morning as pollution levels again slipped to "severe" category. Delhi's AIQ stood at 426 as a result of farm fires in the neighbouring states and vehicular emissions. Full report on Page 2

New Delhi: Hindustan Petroleum Corporation Ltd (HPCL) on Thursday reported ₹2,172.14 crore net loss in July-September after losses arising from freezing petrol and diesel prices couldn't be made up by accounting for a one-time government grant that came after the quarter had ended.

Standalone net loss of \$2,172.14 crore in the second quarter of the current fiscal year compares to \$1,923.51 crore profit in the same period last year, according to the company's filing to the stock exchanges. This is the first time that the company posted a back-to-back quarterly loss. HPCL posted a record of \$10,196.94 crore in the April-June quarter.

Just like HPCL, Indian Oil Corporation (IOC) - the nation's largest oil firm-too had posted a second straight quarterly loss as state-owned firms sold petrol, diesel and cooking gas (LPG) at rates below cost to help the government contain inflation.

The loss in the second quarter of the current fiscal was despite accounting for a one-time grant that the government had announced on October 12 to make up for most of the losses that the oil PSUs had incurred on selling cooking gas LPG below cost in the last


two years.



HPCL said it got ₹5,617 crore "to compensate underrecoveries incurred on the sale of domestic LPG du-

ring the financial year 2021-22 and current period, which has been duly recognised in July-September 2022".

The government had on October 12 extended a one-time grant of ₹22,000 crore to three state-owned fuel retailers to cover for losses they incurred on selling domestic cooking gas LPG below cost in the last two years. — PTI

State-run Hindustan Petroleum Corporation (HPCL) on Thursday reported a consolidated net loss of ₹2,476 crore for the July-September quarter largely on account of losses incurred on freezing of retail prices of petrol and diesel.

The oil marketing company (OMC) posted a net profit of ₹1,919 crore in the year-ago period. However, on a sequential basis, its net loss contracted from ₹8,557 crore in Q1 FY23. HPCL's consolidated total income rose to ₹1.14-lakh-crore this quarter against ₹1.22-lakh-crore in last quarter and ₹88,299 crore in the corresponding quarter last year.

COST DYNAMICS

With changed input cost dynamics during Q2 FY23, the company was able to negotiate better prices and partially mit-

igate the effect of high costs. Nonetheless, high input costs and consequent depressed marketing margins continued to impact profitability, HPCL said in a statement.

Average gross refinery margins (GRMs) (gross of export duty) July-September for quarter were \$8.41 per barrel (\$2.44 a year-ago). HPCL refineries at Mumbai Vishakapatnam processed crude throughput of 4.49 million tonnes (mt) during July-September 2022 (2.53 mt). During Q2 FY23, HPCL achieved total sales of 10.39 mt (9.10 mt) representing a growth of 14.2 per cent.

ONE-TIME GRANT

In a regulatory filing, HPCL said the government recently approved a one-time grant of around ₹5,617 crore to compensate under-recoveries incurred on sale of domestic LPG during FY22 and current period, which has been duly recognised in July-September 2022.

Sri Lanka holds crucial debt restructuring talks with creditors

COLOMBO: Sri Lanka held a "productive" second round of crucial talks with its bilateral creditors, the finance ministry said on Thursday, as the crisishit island nation attempts to get assurances on debt restructuring from them to close a deal with the IMF.

Sri Lanka held talks with the International Monetary Fund on October 16 on the release of a \$2.9 billion rescue package by the Fund, the completion of which hinged on assurances from the country's creditors on debt restructuring.

"Sri Lanka remains fully committed to advancing engagements with all its creditors in an equitable and transparent way. The meeting represented another important step towards securing International Monetary Fund (IMF) Board approval for Sri Lanka's IMF programme", a release said.

Commenting on the meeting the Central Bank Governor Nandalal Weerasinghe said the IMF programme and economic reform agenda will reconstitute Sri Lanka's financial buffers.

He said the meeting was "productive" where they were able "to discuss Sri Lanka's current financial position and progress on reforms."

India, China and Japan are among Sri Lanka's main creditors. Sri Lanka reached a staff-level agreement with the IMF in late August for a \$2.9

billion rescue package over 4 years.

Its completion depends on assurances from Sri Lanka's creditors on debt restructuring.

Sri Lanka has large debt rollover volumes (Gross Financing Need) running up to 37 per cent of GDP in 2022, which the IMF wants to bring down, according to the EconomyNext news portal.

The exact GFN target is not known, but other countries under restructure have levels around 15 per cent, and some less, it said.

President Ranil Wickremesinghe who steers the talks with the IMF said this week he was hopeful of the realisation of the facility by January.

The Sri Lankan government in May appointed international legal and debt advisors for debt restructuring after the country declared its international debt default for the first time in history.

Sri Lanka is nearly bankrupt and has suspended repaying its \$51 billion foreign debt, of which it must repay \$28 billion by 2027.

Sri Lanka, a country of 22 million people, plunged into financial and political turmoil earlier this year as it faced a shortage of foreign currencies.

Due to this, the country has been unable to afford key imports, including fuel, fertiliser and medicine, leading to serpentine queues.

Wrong orientation?

n order to "enable smooth availability" to the farmers during the rabi season at subsidised prices, the Central cabinet approved the new rates of Nutrient Based Subsidy (NBS) for Nitrogen (N), Phosphorus (P), Potash (K) and Sulphur (S) for Phosphatic and Potassic (P&K) fertilisers. Through this move, the Central government seeks to absorb the "volatility in international prices of fertilisers and raw materials" in order to ease the burden from farmers' shoulders. It is true that international energy prices have a direct bearing on the production, import and availability of fertilisers in the country. Heightened energy prices in the wake of the Russia-Ukraine war have made the situation grim. Additionally, Russia, Belarus and Ukraine are the major suppliers of non-urea fertiliser ingredients. The war has led to curtailment of the supply of essential ingredients of such fertilisers, thus hampering production and increasing prices. The war has indeed presented before us an extraordinary situation, and the government's response appears imperative at this juncture. However, it must be pointed out that even before the war, international prices of urea and DAP had risen to "extraordinary" levels by the end of 2021, due to demand-supply and production constraints in main fertiliser producing countries. Though the increase in subsidy for fertilisers is aimed at solving an immediate problem at hand — that of farmers' inaccessibility to high-cost chemical fertilisers, the chronic problems it perpetuates cannot be overlooked. The government's decision can be justified as an emergency response but deserves no applause in the medium and long term, as it extrapolates the ills of India's fertiliser industry. The most prominent fallout of increased subsidy is the huge fiscal burden it puts on the government's coffers. There is a limit to how much the government can "absorb", and for how long. The government's recent move will lead to a total financial outgo of Rs of 51,875. The budgetary allocation for fertiliser subsidy in the rabi season has been extended from Rs 54,500 crore to Rs 1,38,875 crore. With this move, the total subsidy — including both rabi and kharif seasons — would now touch a record high of Rs 2.25 lakh crore for 2022-23. Even much before the war and the pandemic, subsidy for fertiliser had been on the rise. In 2017-18 for instance, the estimated budget for fertiliser subsidy was Rs 66,468 crore, which increased to Rs 79,530 crore in 2021-22. It is no mystery that subsidies for fertilisers have been made to swell massively over the decades against a moderate increase in prices. Taking the case of urea alone, it is reported that taxpayers bear 78 per cent of the cost of urea and farmers pay only 22 per cent. How sustainable this ratio is, needs no explanation! High fertiliser subsidy is not only a fiscal burden for the government, it also promotes disproportionate and inefficient use of fertilisers, affects soil health, adds to the import bill among other things. In terms of imports, the overall figure for India stood at USD 24.3 billion in 2021-2022 alone. Furthermore, Liquified Natural Gas (LNG) is one of the main feedstocks of urea. A large part (over 40 per cent) of India's LNG import goes into the fertiliser sector. Reckless use of fertilisers, urea in particular, will create a burden on LNG imports as well. Call it the circumstances, Indian gov ernment's decision to increase fertiliser subsidy cannot be denounced at the present junction. But, in the medium and long term, there is a need to reform the fertiliser sector. In the first place, India's import dependency in terms of fertilisers needs to be moderated. The government has claimed that India will not import fertiliser after 2025. It remains to be seen to what extent such future claims will fructify. Secondly, India's fertiliser policy will have to be realigned to promote the use of organic fertilisers; at the same time, methods need to be exploited to enhance the nitrogen content of the composts. Use of complexes can also be promoted. Thirdly, greater efficiency has to be introduced in the use of fertilisers by opting for nano and water-soluble variants. Apart from all these, use of harmful fertilisers like urea should be balanced with that of safer types. To sum up, India's fertiliser sector is headed in the wrong direction. Basic re-orientation is the need of the hour.
