Terms & Conditions: 1) Engagement is purely on contract basis. 2) Notice period of one month would be required to be given from either side for termination of contractual engagement, if terminated prior to stipulate period. 3) Terms and conditions of this engagement shall be subject to change(s) from time to time based on Company's latest policy. In case of any conflict, guidelines published by the company through different circulars/ office orders or through its official portal shall be considered as binding. 4) 80% of the monthly honorarium along with the full amount of reimbursement towards conveyance and expenses towards office at residence would be paid on monthly basis. Roles and responsibilities of Junior Consultant during deployment in ONGC Mehsana: The Junior Consultant will look after the under chassis repair and maintenance of Drilling Rigs, Work-over Rigs and Departmental Vehicles (Light, Medium & Heavy) operating in Mehsana Asset. The under chassis work of Drilling Rigs and Work over Rigs include the following: 1) Check the free movement of steering / any oil leakage/ any other damage. 2) Check the oil level in all differentials and top up as per requirement. 3) Check the mounting brackets of all differentials. 4) Check the suspension system of the rig. 5) Check all the air brake chambers for proper operation/ any air leakage/ any air hose damage. 6) Check the foot accelerator valve for proper functioning/ any other damage. 7) Check the condition of all propeller shafts below chassis/ any broken or loose nuts/ condition of u-joint etc. 8) Check the physical condition of all tyres and arrange the new tyre for replacement before moving the rig. 9) Every year, RTO passing of these Heavy Vehicles are required, for which Vehicle fitness is required. These heavy vehicles regularly come to Auto Workshop for servicing and other repairs. 10) Besides that they will also look after the local fabrication and procurement of items. 11) To maintain daily activity report and submit the same to In-Charge Auto Workshop.
