Sub: Bid Evaluation Criteria

While deliberating one of the cases, EPC noted that as per existing standard BEC Clause, the experience / eligibility requirements to be met by a bidder are stated with respect to TBO as reference date. However, as TBO date is prone to extension at the request of bidders in order to widen competition in a tender, this may result into a situation where a bidder may be meeting a particular criteria as on original TBO date but not meeting the criteria as on the actual TBO date and converse may also happen.

In order to avoid above situations, EPC in its meeting (20/2022) held on 23.09.2022 decided that bidder shall be evaluated for eligibility / experience with respect to the originally scheduled TBO date.

Accordingly, relevant provisions of BEC for Procurement of Goods/Service Contracts stands modified as per Annexure-1. Work centres are advised to carry out similar modifications in the BEC provisions for other type of tenders also.

Above guidelines should be meticulously followed by all concerned.
